

Permission Form Governing Use of the Database of Moving Faces and People

Background

The Database of Moving Faces and People was developed in the Perception Lab at The University of Texas at Dallas under the supervision of A. J. O'Toole and H. Abdi. The database development project was funded by DARPA through the Air Force Office of Scientific Research and the Office of Naval Research as part of the Human Identification Project. This database was constructed with the goal of collecting high quality, images and videos of faces and people for research purposes only. The research applications envisaged include perception and memory experiments with human observers and tests of the performance of computational models of face and person recognition.

The database consists of a series of close and moderate range, images and videos of people. The close-range videos capture dynamic information about the face across a range of emotional expressions and poses, and include speech-generated lip-movements. The moderate range videos include dynamic information about individuals who are either actively or passively involved in a conversation. Videos of subjects walking include information about the face, posture, and gait of the individual.
